

## Monthly Yoga Membership Contract



This Membership Contract ("Contract") is entered into between Sedona Star Holistic Spa LLC, hereinafter referred to as the "Studio," and the undersigned member, hereinafter referred to as the "Member." This Contract outlines the terms and conditions of the monthly yoga membership.

### 1. Membership Terms:

1.1 The Member agrees to enroll in the monthly yoga membership program provided by the Studio.

1.2 The membership provides the Member with access to yoga classes conducted at the Studio's premises during the duration of the membership.

1.3 The membership is billed on a monthly basis and will continue until canceled in accordance with the terms outlined in Section 3.

### 2. Payment and Fees:

2.1 The Member agrees to pay the monthly membership fee as stated by the Studio.

2.2 The membership fee is non-refundable and non-transferable.

2.3 The Studio reserves the right to adjust the membership fee with a 30-day notice to the Member.

### 3. Cancellation Policy:

3.1 The Member may cancel their membership at any time with a 30-day written notice to the Studio.

3.2 The Studio will continue to bill the Member's account for the 30 days following the receipt of the cancellation notice.

3.3 The Member is responsible for payment of any charges incurred during the 30-day cancellation period.

### 4. Assumption of Risk:

4.1 The Member acknowledges that participation in yoga classes involves a certain level of physical exertion and may carry a risk of injury.

4.2 The Member voluntarily assumes all risks associated with participation in yoga classes and agrees to release and hold the Studio, its instructors, and staff harmless from any and all liability for any injuries or damages sustained while participating in yoga classes.

**5. Consultation with Medical Professionals:**

5.1 The Member understands that yoga involves physical activity and should consult a medical professional before beginning any exercise program, especially if the Member has any pre-existing health conditions or concerns.

5.2 The Studio recommends that the Member seek medical advice before participating in any yoga class, especially if the Member is pregnant, has a history of cardiovascular disease, or has any other medical condition that might affect their ability to practice yoga.

**6. Compliance with Studio Policies:**

6.1 The Member agrees to comply with all Studio policies and guidelines regarding behavior, attire, hygiene, and conduct during classes.

6.2 The Studio reserves the right to suspend or terminate a Member's membership in the event of non-compliance with Studio policies.

**7. Governing Law and Jurisdiction:**

7.1 This Contract shall be governed by and interpreted in accordance with the laws of The Superior Court of California, County of Orange.

7.2 Any disputes arising from or relating to this Contract shall be subject to the exclusive jurisdiction of the courts located in Fullerton, CA.
